
What is MNT ERA-Net ?

• large European network of national & regional funding programmes for micro and nano technologies (MNT)

- each represented by a funding agency or ministry
- combined annual public budget of 400 M€
- many programmes are targeted at industry

(Coordinator: FFG, Austria) Consortium: 24 partners from 21 countries / regions






Why do we need MNT ERA-Net ?

- Micro and nano technologies are key enabling technologies of the 21st century and the global market is growing rapidly.
- Europe has a strong R&D base in many MNT areas but its funding programmes are fragmented and dispersed among many national and regional funding bodies.
- MNT ERA-Net stimulates close and long-term cooperation between national funding programmes (focusing on applied RTD) to improve and complement the European funding portfolio







Performance of Joint Calls 2006-2008 in MNT ERA.NET




Progress beyond the state of the art Romanian participation




Romania's participation in MNT ERA.NET- Joint calls




Romania – joint calls performance




Topics of the national projects (1)




Call 2008: topics of pre-proposals




Romania's participation in MNT ERA.NET –topics of funded projects




National projects, type of partners




Calls 2006 & 2007 & 2008: type of partners




Romanian participants in MNT joint calls



- good basis for sustained cooperation



- NCPM –the Funding Agency for MNT joint calls
- Funding programme: Partnerships in S&T Priority Areas
- NCPM each Romanian consortium

Standard contract + English version of the project + Consortium Agreement

Contract concluded for the whole duration of the project but, **annual budgets must be confirm, on a yearly basis**

Contractual Procedures/monitoring

• Technical/scientific monitoring against the workplan, objectives, expected results

(project officer)

• Financial monitoring against the financial plan/budget

(project officer +financial officer)



Contractual Procedures/reporting

• 6 monthly/yearly technical and financial reports,

but,

- Compulsory at the end of the budgetary year
- Final report (Partnerships programmes procedure+ summary in English for MNT consortium)

Contractual Procedures/payments

- Pre financing -30% of the annual budget
- Interim payments based on interim evaluation reports
 - » Monitoring reports
 - » External evaluation reports
